## Services may include:

- Adult day healthcare
- Primary medical care and medical specialty services
- On-site specialty services for vision, dental, hearing and foot care
- Prescription drugs
- Laboratory and diagnostic services
- Medical supplies and equipment
- Nursing and preventive health care
- Physical, occupational and speech therapy
- Recreational therapy and special events
- Social work services and family support
- Nutritional counseling
- Meal planning for special diets, meals while at the Center, and home-delivered meals
- Home healthcare
- Personal care and in-home assistance
- Transportation to and from the Center and for medical appointments
- Nursing home care
- Acute hospitalization
- Emergency and urgent care available 24 hours a day, 7 days a week
- Ambulance service



BCSC costs are covered at least in part by Medi-Cal, Medicare and private payment. Your payment will depend upon your Medicare and Medi-Cal eligibility.

If you are eligible for Medicare and Medi-Cal, or if you are eligible for Medi-Cal only without a share of cost, you pay nothing to BCSC.

If you are eligible for Medi-Cal with a share of cost you pay a monthly premium to BCSC. This premium is equal to your share of cost as set by Medi-Cal rules.

If you are eligible for Medicare only, you pay a monthly fee equal to the Medi-Cal payment, including a premium from Medicare Part D medications.

If you are not eligible for Medicare and Medi-Cal, you pay a monthly fee equal to the Medicare and Medi-Cal payment.

BCSC enrollees must get all care, including primary care and specialty physician services (other than emergency care), from BCSC or a place we authorize to provide care and may have to pay the costs of unauthorized or outof-program services.


Our friendly staff will answer your questions and help assess whether BCSC will meet your needs.


# Program of All-Inclusive Care for the Elderly (PACE) WEST LOS ANGELES

All of us want to live and age in the home we love. At Brandman Centers for Senior Care, we can help make this a reality for you or a loved one.

Brandman Centers for Senior Care (BCSC) is a program of the Los Angeles Jewish Health. Our program is modeled after a nationally recognized health plan called the Program of All-Inclusive Care for the Elderly (PACE).

BCSC is licensed by the State of California and monitored by the California Department of Health Care Services (DHCS) and the Centers for Medicare and Medicaid Services (CMS).

Our primary goal is simple — provide affordable, high-quality health and long-term care services for the well-being of participants and the communities we serve.





Who is eligible to enroll?

BCSC enrolls elderly individuals with multiple health problems. We help them to live with dignity in their own homes, for as long as possible. Participants are:

- Age 55 years and older
- In need of a nursing home level of care
- Able to live in the community when enrolling without danger to their health or safety
- Living wihin the BCSC service area

BCSC supports family members and other caregivers of enrolled seniors with education training and respite care.

Enrollment is voluntary. A participant may disenroll at any time.

The BCSC PACE Center is open five days a week (excluding holidays) year-round, from 8:30 a.m. to 5:00 p.m. A participant may attend the PACE Center one to five days a week, depending upon need. Care is available 24 hours a day, 7 days a week.

#### Here's how we can help.

BCSC Primary Care Providers see participants mainly at the PACE center. Should a participant require a level of care, the team will arrange for nursing home care or approve home healthcare services. As a result of day-by-day coordination and monitoring, participants may have fewer health crisis and better overall health. The BCSC Interdisciplinary Team develops an individualized plan of care. Our Interdisciplinary Team includes:

- Center Manager
- Primary Care Provider
- Medical Specialists
- Enrollment Representative
- Nurse
- Social Worker
- Recreation Therapist
- Occupational, Physical and Speech Therapists
- Dietitian
- Personal Care Attendants and others who provide care for you who provide care for you.
